

## Southern Research Non-Sensitive Area Access Agreement

This form must be completed before a visitor may enter Southern Research's campus.

This Southern Research Non-Sensitive Area Access Agreement ("Agreement") outlines the terms for campus access granted by Southern Research Institute ("SR"). The individual signing this Agreement ("Signatory") acknowledges and understands that SR is granting permission for the "Visitor" (defined herein as the Signatory, or a minor identified below for whom the Signatory acts as Parent or Legal Guardian) to visit the SR Campus. This permission is conditional upon the Signatory agreeing that the Visitor will be bound by the terms and conditions set forth below.

The Signatory understands and agrees that the Visitor's access to the SR campus may be terminated immediately, limited, or prohibited by SR if the Visitor fails to comply with these terms and conditions. The Signatory further acknowledges and agrees that SR reserves the right to terminate this access permission at any time, for any reason or no reason, at its sole discretion. If signing as the Parent/Legal Guardian of a minor Visitor, the Signatory understands that all obligations herein apply to the minor Visitor and/or the Signatory, as applicable.

- 1. Visitor understands that they must be escorted by an authorized site representative at all times during their access to SR's campus/facilities. Visitor understands that unescorted access is not permitted, and that they shall remain with their escort at all times and to follow all instructions given by the escort.
- 2. Visitor agrees to comply with all security procedures, including signing in and out at SR's campus entrance/security desk, wearing an identification badge, and submitting to any required security screenings. Visitor understands that all unauthorized access to restricted areas is prohibited. Visitor will not bring any unauthorized materials or devices (other than a cell phone and/or laptop computer) onto SR's campus. Visitor agrees that they will not take any photographs, videos or sound recordings while on SR's campus, other than those that may be taken by a minor participating in a STEM Program in the Martin Library and/or the STEM Education Outreach Center, as permitted by the STEM Program.
- 3. Visitor understands that SR conducts business that involves the use of chemical, radiological and biological materials, and that such business activities are or can be inherently hazardous. Visitor understands that access to SR's campus is not risk free, even if the Visitor does not have access to laboratories, containment areas or other hazardous areas, and that there are risks and hazards associated with entry onto or other proximity to SR's campus. Visitor agrees to follow all instructions provided to them by authorized SR personnel. Visitor also agrees to report any incidents, accidents or biological exposures to SR.
- 4. Signatory, on behalf of themselves and, if applicable, a Visitor who is a minor, hereby releases and holds harmless SR, its officers, directors and employees, from any and all liability for personal injury or loss of life sustained by Visitor as a result of a visit to SR's campus. Signatory, on behalf of themselves and, if applicable, a Visitor who is a minor, further agrees to indemnify SR, its officers, directors and employees from all claims, losses, or damages brought by third parties, including SR's clients and customers, resulting from Visitor's willful or negligent acts or omissions while on SR's campus. The release of liability and indemnification obligations survive the termination of this Access Agreement and the Visitor's presence on SR's campus.
- 5. Visitor understands that during Visitor's access to SR's campus, they may have occasion to observe or overhear business operations/communications of SR and/or of third parties who/which are in business relationship with SR. Visitor understands all information discussed, overheard and/or viewed, including information viewed/overheard during tours, is considered SR/third party confidential information, and they will maintain the confidentiality of all



such information encountered during their access to SR's campus. Visitor understands and agrees not to disclose, copy, or use any of such information without prior written consent from SR.

6. Signatory hereby gives consent for SR to use Visitor's image and name in any publication or promotion relating to its business. If applicable, Signatory hereby gives permission for SR to use the image and name of the Visitor who is a minor listed below for any non-commercial use, including but not limited to publications and other uses relating to the STEM Program. The consent granted in this section provides SR with the right to use, re-use, publish, re-publish, copy, publicly display, exhibit, distribute and to make derivative works of any photograph, recorded image, video, interview of/with Visitor, and with respect to a Visitor who is a minor, his/her participation in the STEM Program any samples of their work. All such use is granted to SR without any compensation to Signatory/Visitor. SR shall retain title to any and all copyright created in connection with such photographs, recorded images, videos, interviews, or samples or their use as contemplated hereunder. Signatory hereby waives for themself, and if applicable, in connection with the minor identified below, the right to review and/or approve any use contemplated hereunder. Signatory, on behalf of themselves and, if applicable, a Visitor who is a minor, hereby releases and forever discharges SR, its officers, directors, and employees from any and all claims and demands arising out of or in connection with this consent, including but not limited to, any claims for invasion of privacy, appropriation of likeness, or defamation.
